### Capacity Building Workshop for the Ward Councillors on 74<sup>th</sup> Amendment Act, 1992





FST recently organized a capacitybuilding workshop for the Ward Councillors of Guwahati Municipal 74<sup>th</sup> Corporation (GMC) on the Constitutional Amendment Act, 1992. About 30 GMC ward councillors participated in the workshop. Advocate Angan Kumar Baruah from Guwahati High Court facilitated the workshop. The main objective of this workshop to provide comprehensive understanding of the 74<sup>th</sup> Amendment Act, focusing on its significance in empowering local governance structures.

The workshop started with the resource person informing the participants about the 74<sup>th</sup> Amendment Act and its importance for the ward councillors to function. The ward councillors shared their doubts and questions about the 74<sup>th</sup> Amendment Act. Throughout the discussion, numerous inquiries arose, all effectively addressed by the resource person. Queries such as, how to inform the public about the GMC Act, whether it can be changed or not, what kind of work done by ward councillors concerning citizens is considered unconstitutional, etc came out during the session. Additionally, the Mayor expressed gratitude to the FST team and proposed further workshops in collaboration with GMC shortly.

#### Session on Urban Governance for the Senior Citizens



In March, we conducted an interactive session for the senior citizens on engagement in matters related to urban governance. About 10 senior citizens participated in the session and shared their experiences and insights related to their ward. The objective of this session was to create consciousness among the citizens regarding their duties and responsibilities as an active citizen of society.

The session started with an introduction of the 74th Amendment Act and how it is important for the citizens. The session shifted to an interactive discussion where the participants shared their issues related to Ward 32, which needs to be taken in the ears of Guwahati Municipal Corporation (GMC).

During the session, many issues came out such as one of the citizens sharing about fuse street light issues, the degraded condition of the footpath, garbage, water, sanitation, etc. The session was concluded by sharing examples of other wards collectively solving the problems related to their wards. The session inspired the participants to follow their duties and responsibilities as active citizens of society.

This initiative is part of our project Niroopan, which focuses on the engagement and exchange of dialogue between the citizens and Urban Local Bodies (ULB) on matters related to the ward.

#### **Workshop on Building Tools to Engage with Boys**

We conducted a workshop for the 15 young women leaders from Barpeta on how to engage young boys on gender issues.

Nilanju Dutta, a gender rights specialist from North East Network was the resource person. The session shed light on gender, patriarchy, and gender-based restrictions that exist in society. This session is a part of our Ankuran project which focuses on girl's education and empowerment.

Discussions revolve around societal obstacles and limitations faced by both girls and boys, with a focus on empowering young girls through education and fostering an awareness of gender dynamics present in society. During the session, Nilanju introduced tools to help the girl leaders engage with boys. Tools such as body mapping were discussed in detail as to how they need to be executed in the field among young girls and boys to initiate conversation around gender.



Girl leaders were able to understand how gender is a social construct, and what leads to differences between girls and boys which are the contribution of how a society teaches girls to think of themselves as lesser than boys. Through this workshop, they understand the prejudices they hold when it comes to gender. Which they said would be helpful for them to the ideas reconstruct of patriarchy built in them through life experiences.
